INTERNET ACCESS TO WASHINGTON COUNTY'S TAX & ASSESSMENT INFORMATION

Go to Washington County's website - <http://www.co.washington.wi.us/>

Click "Tax/assessment Information" on the left hand column. You are brought to the **Washington County Ascent Land Records Suite**.

You will be able to access tax, payment, assessment and property information by providing **one** of the following search methods:

Municipality (Drop Down list) & Tax Parcel ID

Street Number or Name (separate fields – just enter street name & not Rd, St. Ave. etc)

Last Name

If you need to do another search, be sure that you click the **Clear Search Results** above the municipality.

The Village will be using the County Ascent Land Records Suite to input your tax payments. Payment information will be available immediately. **THE VILLAGE WILL NO LONGER MAIL PAYMENT RECEIPTS.**

How to Pay your taxes:

BY MAIL: THROUGH FEBRUARY 7TH!! Use the enclosed envelope or the address below. This is a lockbox which delivers directly to US Bank. Checks should be made payable to Village of Germantown. Remember to endorse any escrow check. **The lock box will close as of February 8th, any payment** received after that date will be forwarded to Washington County.

Payments **after** February 7th, should be sent to: **Washington County Treasurer, PO Box 1986, West Bend, WI 53095-7986.** (**Business Personal Property** tax bills should always be sent to Village of Germantown)

IN PERSON: Germantown Village Hall, N112 W17001 Mequon Road, from 8:00 AM to 4:30 PM, Monday through Friday, through February 7th, with the exception of the following dates:

CLOSED - December 24th, 25th, 31st & January 1st.

US BANK: County Line Road - will accept payments at the branch office at N96 W18480 County Line Road during their regular business hours and **only through January 31, 2019**. This is a Payment location only, questions on your bill should be directed to Village Hall.

ONLINE: Pay taxes online, through February 7th, 2019 by using:

All fees are the responsibility of the taxpayer. The Village does not receive any portion of the fee.

E-Check: \$1.50 up to \$10,000 or \$10.00 for amounts over \$10,000

Credit/Debit Card: 2.39% of the payment amount (minimum fee \$1.50) VISA, Mastercard, Discover

Second installment payments should be made through Washington County's Online Portal.

DROP BOX LOCATION: Through February 7th, 2019 - Front door of Village Hall, (Door under the Clock Tower) use the Recreation Department receptacle

Payments will be credited on the date received by Village staff.

Reminder: Refund checks will be mailed separately and will take up to three weeks

DOG AND CAT LICENSES

Village Ordinances require all dogs and cats in the Village to be licensed yearly. Please complete the application, and mail it to the **Village of Germantown, PO Box 337 Germantown WI 53022**. Your license will be returned to you by mail. **It is required that your license show the pet's rabies vaccination number and expiration date.**
